RE: BOARD OF COUNTY COMMISSIONERS AUTHORIZES THE ESTABLISHMENT OF THE ALLEN COUNTY HEALTHIER BUCKEYE COUNCIL IN ACCORDANCE WITH OHIO REVISED CODE SECTION 355.02.

The Board of County Commissioners of Allen County, Ohio met in regular session on the 29th day of March, 2016 with the following members present: Greg Sneary, Jay Begg and Cory Noonan

Commissioner Begg moved the adoption of the following:

RESOLUTION

WHEREAS, Ohio HB196 requires the Board of Allen County Commissioners to designate a local Healthier Buckeye Council; and

WHEREAS, pursuant to Ohio Revised Code Section 355.02, the Board of Allen County Commissioner may adopt a resolution to establish and specify the organization of a local Healthier Buckeye Council; and

WHEREAS, the Board of Allen County Commissioners designates the Allen County Family and Children First Council members to serve as members of the Allen County Healthier Buckeye Council; and

WHEREAS, the purpose and goals of the Allen County Family and Children First Council align with those of a local Healthier Buckeye Council; and

WHEREAS, the membership of the Allen County Family and Children First Council has representatives from public and private entities consistent to those notes within Ohio Revised Code 355.02; and

WHEREAS, the Board of Allen County Commissioners is designated as the staffing agent and the Allen County Treasurer is designated the fiscal agent for the Allen County Healthier Buckeye Council; and

WHEREAS, Ohio Revised Code Section 355.03 provides that the Allen County Healthier Buckeye Council generally shall promote cooperation and coordination to maximize opportunities for individuals and families to achieve and maintain optimal health in all aspects, thereby achieving greater productivity and reducing reliance on publicly funded assistance programs; and

WHEREAS, the Allen County Healthier Buckeye Council may apply for, receive and oversee the administration of grants; now therefore






