RESOLUTION 2016 - 70

RESOLUTION ---- DESIGNATING FAMILY AND CHILDREN FIRST COUNCIL (FCFC) TO ORGANIZE AND SERVICE AS THE SANDUSKY COUNTY HEALTHIER BUCKEYE COUNCIL

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 29th day of March, 2016 at the offices of the Board with the following members present:

Charles Schwochow

Terry Thatcher

Commissioner Schwochow moved the adoption of the following resolution:

Whereas, each Board of County Commissioners may adopt a resolution to establish a local healthier buckeye council, and,

Whereas, if a local council is established, the Board of Commissioners shall specify the organization of the council and shall designate a member to serve as a staffing agent and, if the board determines necessary, a member to serve as a fiscal agent, and,

Whereas, pursuant to ORC 355.02, the Sandusky County Board of Commissioners is responsible for organizing a local healthier buckeye council to provide care coordination services, provide or promote private employment or educational services, or otherwise contribute to the well-being of individuals or families, and,

Whereas, the Sandusky County FCFC is broadly representative of the groups and individuals and the public and private entities that have an interest in education and employment services provided in the county, WSOS serves the county as a collaborator for this type of service and Sandusky County Jobs and Family Services (SCDJFS) has the ability to assist as a fiscal agent for such council.

THEREFORE; Be It Resolved,

Section 1. The Sandusky County Board of Commissioners hereby establishes a local healthier buckeye council.

Section 2. The Sandusky County Board of Commissioners do hereby designate the Sandusky County FCFC to serve as the Sandusky County Healthier Buckeye Council and will serve as the staffing agent, WSOS will serve as the lead collaborator and SCDJFS serve as the fiscal agent for said council.

Section 3. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.
